## **FEE SCHEDULES**

Effective: January 1, 2024

## **CALIFORNIA RATES**

For live and virtual mediations and arbitrations in California, Mr. Robertson's half-day fee is \$2,500.00 and the full day fee is \$4,500.00. A half day consists of 4 hours of session time and a full day consists of 8 hours in session. After 8 hours, time is billed at rate of \$525/hour. Travel time is included within these rates and not billed separately.

For mediations and arbitrations outside California, Mr. Robertson's fees are as follows:

## **OTHER STATES**

A flat fee of \$7,000 per day will be charged for cases in all other states which is *inclusive* of all travel time and expenses. After 8 hours, time is billed at rate of \$525/hour. Travel time and expenses are included within these rates and not billed separately. No half-day fee option for other states.

## ADMINISTRATIVE CHARGES

There are no administrative charges of any kind.

## **BILLING**

Unless otherwise agreed to by the parties, fees will be divided equally among all participants and billings will be sent out within five (5) business days after the reserved date has been confirmed.

## REFUND OF FEES/CANCELLATION FEE

Fees are fully refunded when notice of cancellation is received at least fourteen (14) calendar days before the scheduled date. There is a 50% cancellation charge when notice of cancellation is received less than 14 days before the scheduled date.
